NOTICE OF PUBLIC HEARING NOTICE IS HEREBY GIVEN that the County Legislature of the County of Chemung, New York, will meet at the County Legislature, 5th Floor, Hazlett Building, 203 Lake Street, in Elmira, New York, on March 11, 2024, at 6:50 o'clock .P.M., Prevailing Time, for the purpose of conducting a public hearing in relation to the proposed increase and improvement of facilities on behalf of Sewer District No. 1, consisting of various sewer improvements, including UV rebuild, and replace collections roof and IDA Pump Station, all as set forth in the map, plan and report prepared in connection therewith, at a maximum estimated cost of \$528,500. The estimated annual cost to the typical property owner in the District as a result thereof is \$8.81; and proposed increase and improvement of facilities on behalf of the Chemung County Elmira Sewer District consisting of various sewer improvements, including engineering/design costs, Pump Station construction, manholes, collections roof replacement and other incidental improvements, all as set forth in the map, plan and report prepared in connection therewith at a maximum estimated cost of \$428,500. The estimated annual cost to the typical property owner in the District as a result thereof is \$4.14.
